## FY2025 Q1 Highlights

- FY2025 Q1 underlying operating CF was **¥250.4 billion** and consolidated net income was **¥203.1 billion**.
- Underlying operating CF was largely in line with full-year guidance of ¥900 billion at 28% progress, although there is variability across segments due to the timing of dividend income.
- Similarly, consolidated net income showed 29% progress against full-year guidance of ¥700 billion. The slightly higher performance was driven by capital recycling gains and one-time items across multiple businesses.

## Progress of Corporate Strategy 2027

- “Enhance”:
  - Shipped first cargo from LNG Canada (June 30, 2025).
  - Cermaq agreed to acquire three salmon farming businesses from Grieg Seafood ASA (announced July 17, 2025).
- “Reshape”:
  - Completed tender offer for shares in Mitsubishi Shokuhin Co., Ltd. (July 8, 2025).
- “Create”:
  - Announced our intention to acquire additional shares in Thai Union Group PLC, a major global seafood company, to make it an equity-method affiliate (August 4, 2025).
  - Participated in renewable fuel production and sales business (announced July 22, 2025).

# Summary Results for FY2025 Q1

- Progress of both underlying operating CF and consolidated net income was largely in line with full-year guidance.
- Steady progress was also made in our ¥1 trillion share buyback program, which was announced on April 3, 2025.

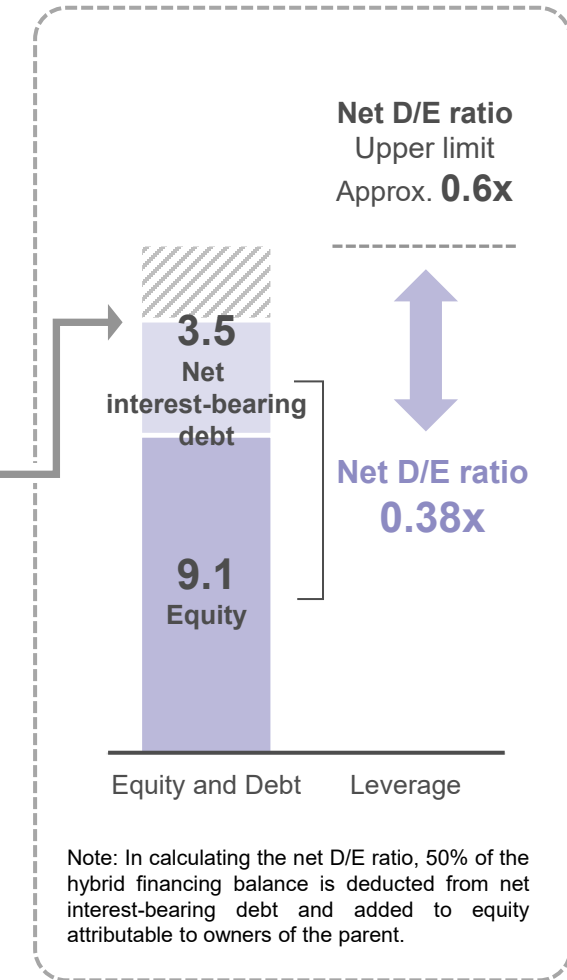

## LNG Canada (Canada)

- The **first LNG cargo was shipped** on June 30, 2025. Currently, efforts are focused on starting up and stabilizing operations toward the maximum production capacity (14 MTPA).
- This project has **geographical advantages** due to its close proximity to Asia including Japan, and because it does not require passing through key chokepoints like the Strait of Hormuz or the Panama Canal.
- An **expansion plan to double the project’s production capacity** is under consideration in collaboration with our partners.
- Through this project, we liquefy natural gas produced from our active shale gas production business and sell it as LNG, primarily to Asia.
- With the start-up of this project, our total LNG equity production capacity will **increase from 13 MTPA to 15 MTPA**.

## Mitsubishi Shokuhin (Japan)

- On May 8, 2025, we announced our intention to make a tender offer for shares in Mitsubishi Shokuhin Co., Ltd. **to make it a wholly-owned subsidiary** (it is currently a 50.1% owned subsidiary). The completion of the tender offer was announced on July 9, 2025 (total acquisition amount of approximately **¥138 billion**).
- We will strengthen our wholesale business functions by increasing touchpoints between our food-related companies, and streamline supply chains by combining our digital expertise with Mitsubishi Shokuhin’s transaction-related data.
- In addition to our Japanese wholesale business, **we will aim for expansive growth, including through M&A**, by combining our segment’s expertise across logistics, overseas wholesale, digital marketing, and other areas.

## Cermaq Group (Norway / Canada)

- On July 17, 2025, our wholly-owned subsidiary Cermaq Group AS (Cermaq) announced that it has agreed to acquire **three salmon farming businesses** from Grieg Seafood ASA, **located in Northern Norway and on the East and West Coasts of Canada.**
- In anticipation of a tightening of supply-demand for salmon over the medium to long-term, Cermaq is focusing on expanding production, improving productivity, and strengthening its processing capabilities. This acquisition will **enable Cermaq to significantly expand** its core Norwegian business and further expand its Canadian business, which has strong access to the U.S. market.
- Through this acquisition, Cermaq will become **the world’s second-largest producer\*** by production volume, with output expected to increase from the current approximately 200,000 tons per year to about **280,000 tons per year by FY2027.**

### Salmon farming sites subject to acquisition

#### Northern Norway

- Acquisition of operations in the **Finnmark region**, where Cermaq already has farming sites.
- With proximity to existing farming sites, the acquisition is expected to **enable knowledge sharing and increase productivity.**

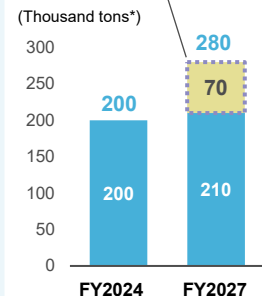
#### East and West Coasts of Canada

- Acquisition of operations in **British Columbia**, where Cermaq already has farming sites, and in **Newfoundland and Labrador**, where Cermaq has not yet entered.
- A key advantage is the potential for **land-based transportation to the U.S.**, where demand for salmon is expected to increase.

## Thai Union Group (Thailand)

- On August 4, 2025, we announced our intention to acquire approximately **14% of the outstanding shares of Thai Union Group PLC\*** (TU) through a general offer to make TU an **equity-method affiliate**. MC’s current stake is approximately 6%.  
\*TU’s market capitalization: approx. THB 43 billion (approx. ¥195 billion) as of July 31, 2025
- TU is a **major global seafood company** that processes seafood such as tuna, from head to tail, into value-added products such as canned seafood, pet food, aquatic feed, and functional ingredients. TU’s main markets include Europe, the United States, and Asia, and it holds a **world-leading market share** in core product categories including canned tuna and wet pet food.
- Through this acquisition, we will closely engage with TU, which is expected to achieve stable growth by leveraging its processing and value-added functions for seafood, as well as its global procurement and sales capabilities. By accelerating TU’s growth through synergies with our existing businesses, we aim to **create a new earnings driver in the seafood business, following our salmon farming business.**

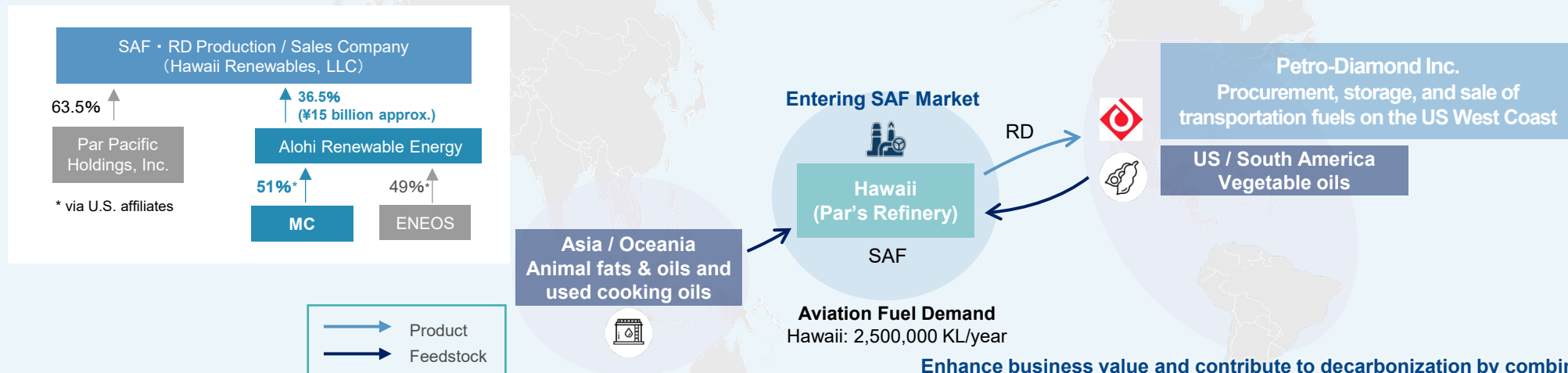

## Participation in Par Pacific’s renewable fuel production and sales business (U.S.)

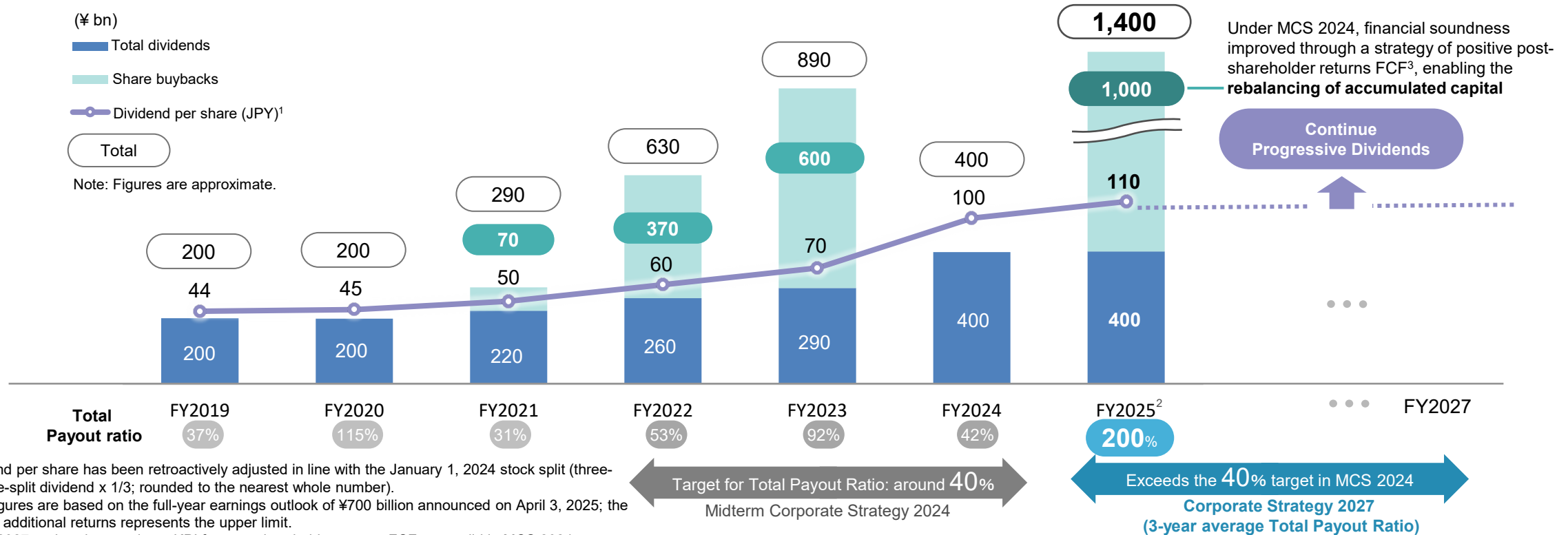
- On July 22, 2025, we signed a definitive agreement with Par Pacific Holdings, Inc. and ENEOS Corporation to establish Hawaii Renewables, LLC, a joint venture to produce renewable fuels at Par Pacific’s refinery in Hawaii.
- This business will be able to produce 150,000 KL of Sustainable Aviation Fuel (SAF) annually, with the flexibility to adjust the production ratio to Renewable Diesel (RD) and others depending on demand. The facility is scheduled to start operations within 2025.
- MC will leverage the **expertise of the Food Industry segment and its networks, including our strategic partner, ADM** (Archer-Daniels-Midland Company), to procure biomass feedstocks (such as vegetable oils, animal fats and oils, and used cooking oils), as well as our **global network in the fuel business developed by the Environmental Energy segment**, to enhance business value and contribute to decarbonization by appropriately addressing customer needs.



Enhance business value and contribute to decarbonization by combining the expertise and functions of the Environmental Energy and Food Industry segments

## CS 2027: Maintain progressive dividends and flexible share buybacks.

- **Dividend Policy:** MC will continue to implement progressive dividends based on the dividend amount per share, any further dividend increases will be determined after assessing profit and underlying operating CF improvement. In FY2025, the dividend per share will increase from ¥100 to ¥110.
- **Share buybacks:** In a potential excess cash scenario, we will flexibly decide on the appropriateness of allocating funds to investments or additional shareholder returns, in consideration of the status of our investment pipeline.
- **Total payout ratio:** Although there is no total payout ratio target for CS 2027, the three-year average total payout ratio for FY2025 to FY2027 is expected to exceed the 40% target set under Midterm Corporate Strategy 2024 (MCS 2024).

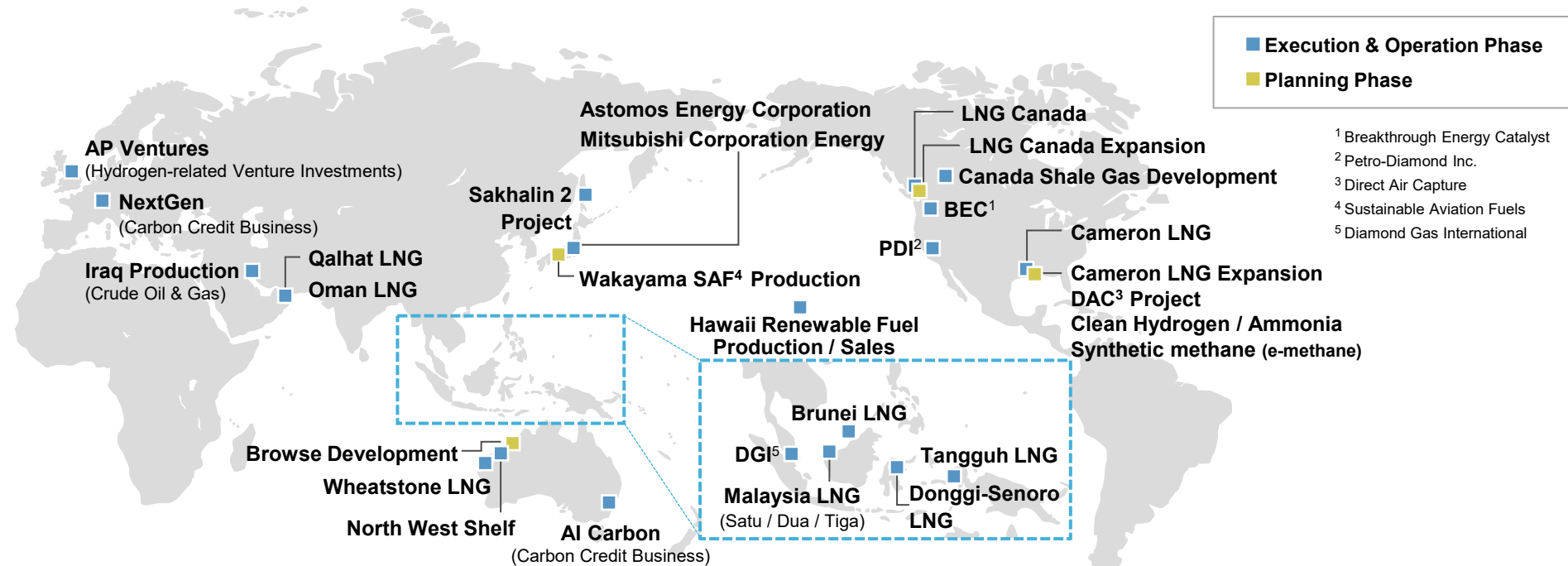

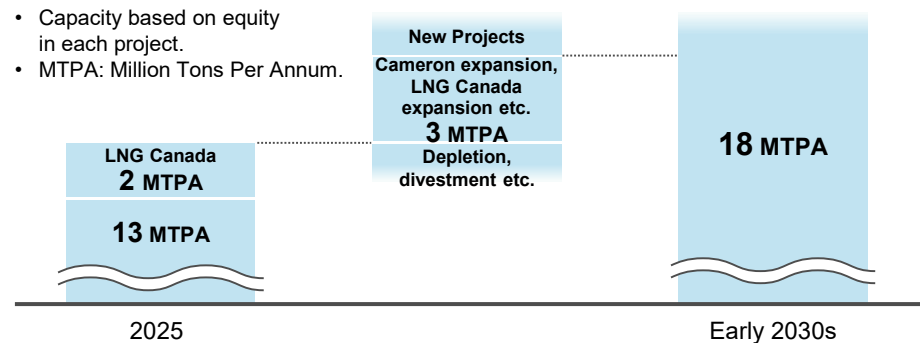

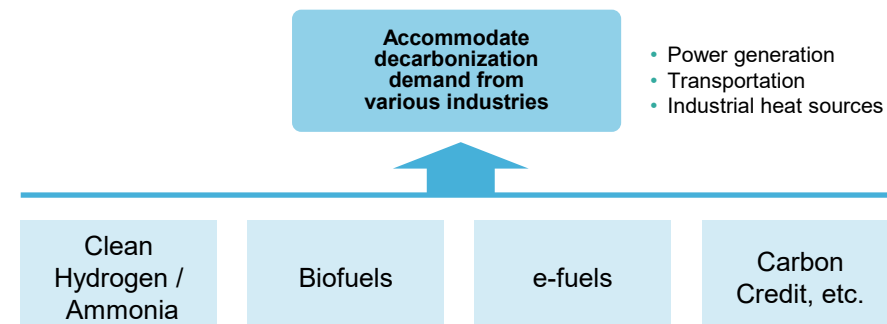


### Growth Outlook of LNG Equity Production Capacity

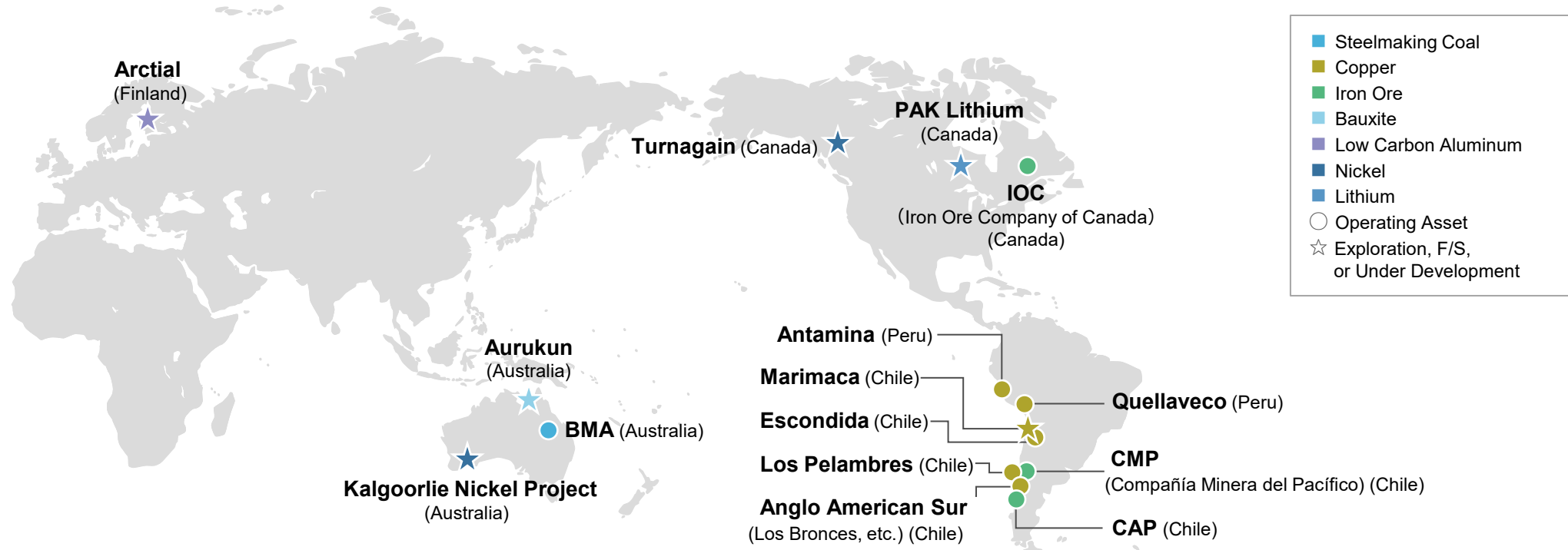

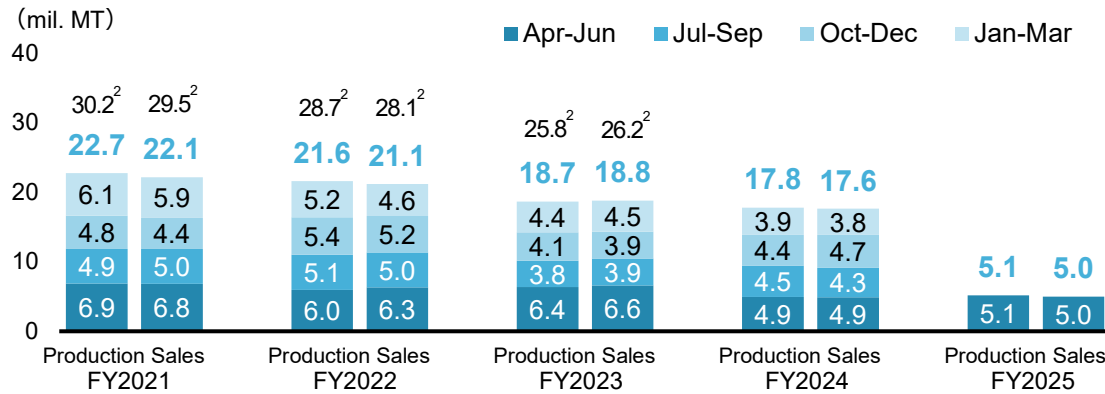

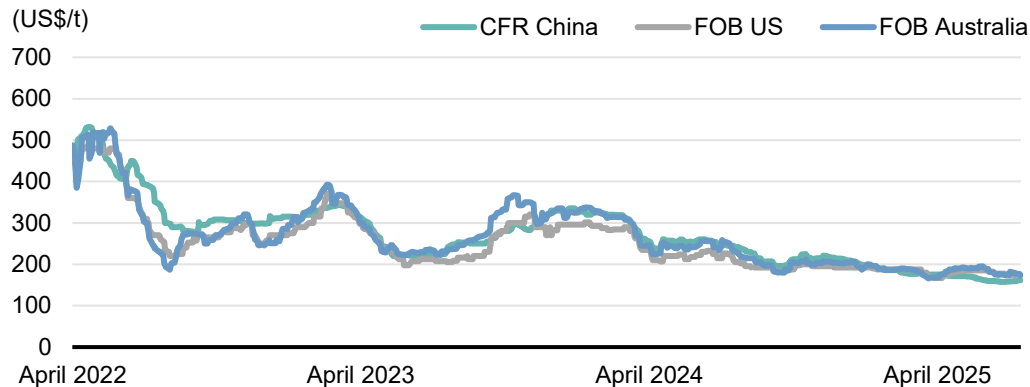
## Mineral Resources: Steelmaking Coal Operation

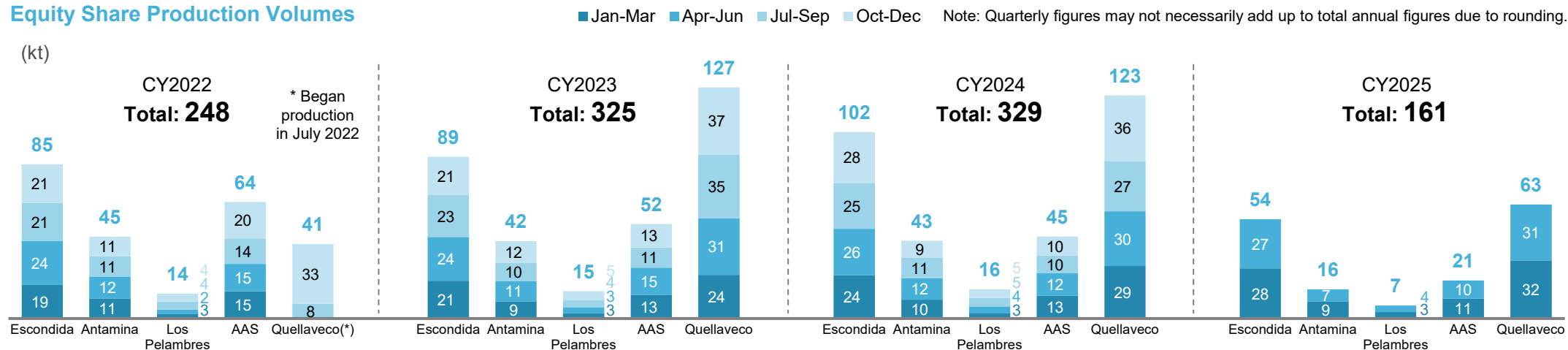

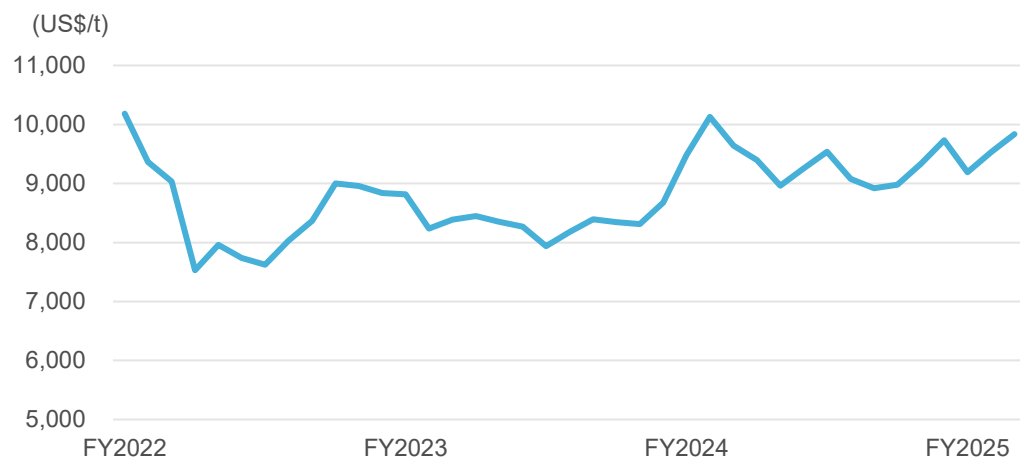
- Since 2024, steel exports from China have increased, supported by easing supply-demand in the domestic market. This has led to a global oversupply of steel, resulting in lower steel prices, compressed mill margins, and subdued demand for steelmaking coal. China's steel exports exceeded 100 mil. MT in 2024, reaching a record high, and continue at a pace of 10 mil. MT per month in 2025. While demand for steel and steelmaking coal is rising in India, trade volumes of steelmaking coal are declining in Japan, South Korea, and Europe.
- Since April 2025, two major Australian coal mines have suspended operations due to production issues. In addition, several mines in Australia and the United States have scaled back or partially suspended operations in response to deteriorating market conditions. Meanwhile, steelmaking coal production in China and exports from Mongolia and Russia remain strong.
- As a result of these dynamics, the Free on Board (FOB) Australia price for premium hard coking coal reached a low of US\$166/t in March 2025 and has since remained in the US\$170/t range as of mid-July.

#### Quellaveco (AAQ)

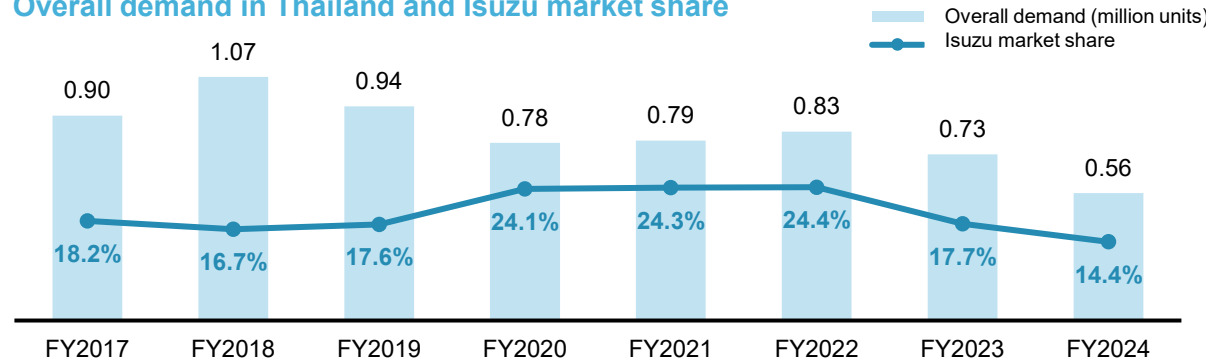

- In the European market, as in the previous period, seawater temperatures in Norway have remained above average, supporting strong fish growth across the industry. This has resulted in a substantial increase in supply, leading to a decline in market prices to 70.25 NOK/kg by the end of June.
- In the U.S. fillet market, an import tariff was raised in April and the prices temporarily rose due to Easter demand. After Easter, seasonal demand declined as expected, and the drop in European prices led to increased exports of Norwegian salmon to the U.S. As a result, prices gradually fell, reaching 5.55 USD/lb by the end of June.
