Regarding New Structure and Executive Staff for FY2008

1. Background and Aims

- (1) Picking up on worldwide changes and maintaining growth on a global basis requires a corporate structure that is highly efficient in tapping into both regional and industry-specific growth, as well as strong execution in management. Furthermore, due to an increasing number of large investment projects and important issues concerning two or more Business Groups, there is a greater need to strengthen management functions and expedite decision-making processes.
- (2) Accordingly, changes to MC's management structure will be made from the following three perspectives, in order to promote the company's next management plan, following INNOVATION 2007 (the new plan is currently under development).
 - (i) Strengthening companywide management functions for strategic planning and decision making, from medium-, long-term, and companywide perspectives.
 - (ii) Strengthening execution in sectional management*, and bolstering and expediting decision making and execution.
 - (iii) Further separating roles and responsibilities of directors and officers, and strengthening officers' supervisory functions.
 - (*) "Sectional management" refers to management in the Business Groups and Corporate Staff Section

2. Effective Measures

(1) Review of Management Meetings

Meetings to "determine important items under companywide management", and for "officers to discuss and share information pertaining to management strategies and key issues", will be clearly delineated, and each strengthened accordingly.

(i) Review of Executive Committee (April 1st)

To be comprised of officers responsible for companywide management,

and to function as a decision-making body for important, management-related issues.

(ii) New Establishment of Group CEO Meeting (April 1st)

To involve officers responsible for companywide and sectional management and to function as a meeting in which these officers can discuss and exchange opinions on strategy and important, management-related issues, and where they can share management information.

(iii) Review of the Board of Directors (to be implemented at the Annual Shareholder's Meeting in June)

 From the perspective of further separating officers and directors, executives currently sitting as concurrent board members shall be narrowed down to those responsible for companywide management.*
 The Board of Directors shall be comprised of the Corporate Auditors and both internal and outside directors responsible for companywide management, and its supervisory functions is to be strengthened.

(2) Strengthening Companywide Management Functions

(i) Clarification of Roles of Senior Executive Vice Presidents (Mission for SEVPs in Charge of Business Fields)(April 1st)

- In their capacity as members of both the Executive Committee and Board of Directors, the SEVPs shall take part in decision making on companywide management. They shall assist the President with various Committees and in dealing with important issues.
- As part of this, some SEVPs shall be appointed from the perspective of business operations to assist the President, and shall bear certain responsibilities with regard to the following: CRM for important customers, important regional strategies, and important fields / separate matters that fall under business strategies.

(ii) Strengthening system to promote Global Strategy (April 1st)

• In order to strengthen the planning and promotion of regional strategies from a global perspective, Regional CROs shall be

assigned to five regions throughout the world (the Americas / Europe, Africa, the Middle East and CIS / China / Asia and Oceania / Japan). These Regional CROs shall assist the Corporate Functional Officer (Global Strategy)*.

(3) Strengthening Execution of Sectional Management (Review of Discretionary Authority) (to be implemented after April 1st)

GCEOs shall be given more authority independent of the Executive Committee, on matters such as investments and loans. Through a review of the Management Meetings, a system shall be established in which the GCEOs can focus more on Group management than in the past. They shall be given more discretionary authority to expedite the decision making process.
