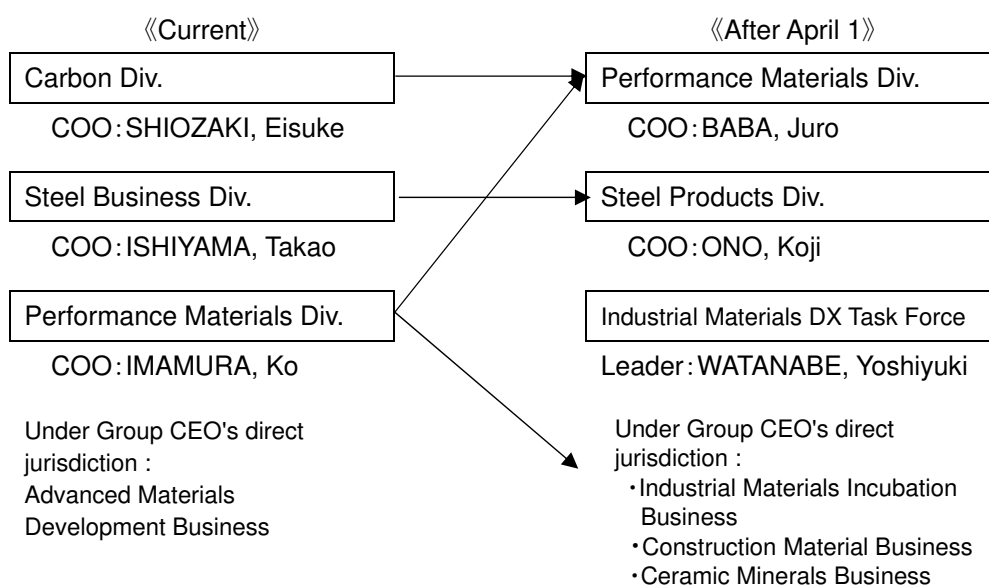

【Reference 2】 Summary of Reorganizations (as of April 1, 2021)

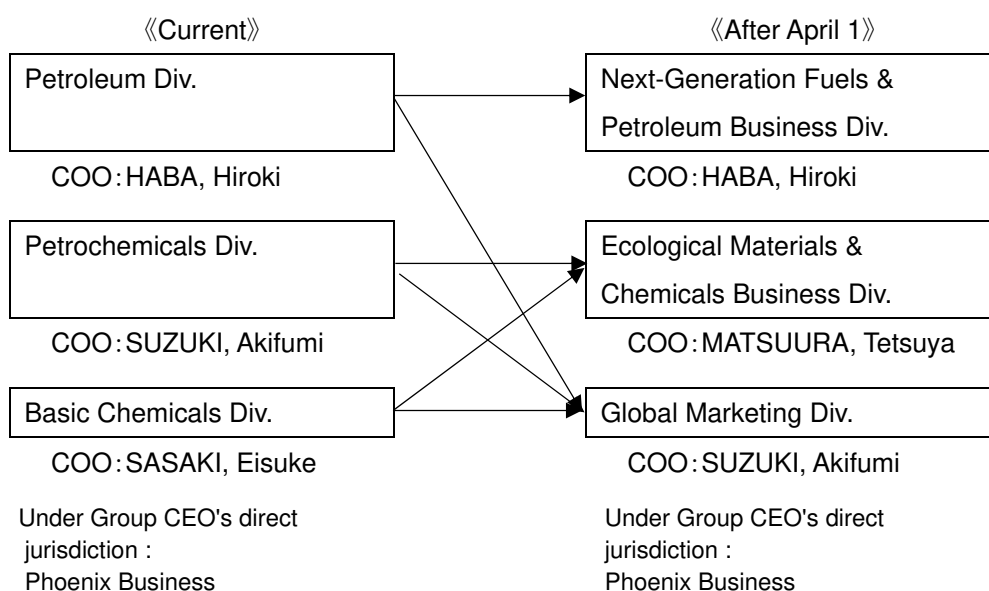
1. Industrial Materials Group

- In order to strengthen the Industrial Materials Group's profit base and accelerate its business model reforms, its carbon and functional materials businesses shall be consolidated within the newly established Performance Materials Division.
- The Industrial Materials DX Task Force shall be newly established to promote digital transformations throughout the group's businesses.



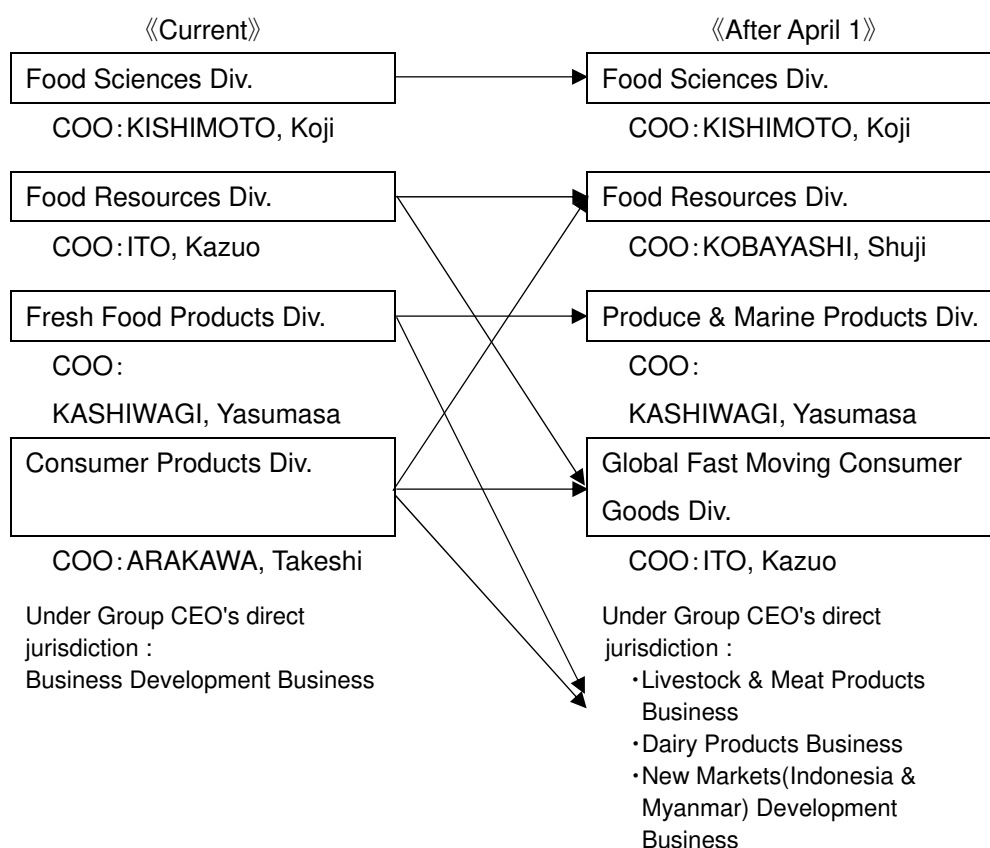
2. Petroleum & Chemicals Solution Group

- The divisions of the Petroleum & Chemicals Group shall be reorganized to focus either on business development and investment, or on trading.
- The Next-Generation Fuels & Petroleum Business Division shall be responsible for business developments and investments in petroleum and electric power, as well as all fuels-related transactions. The Ecological Materials & Chemicals Business Division shall be responsible for business developments and investments in petrochemicals and basic chemicals. Both divisions shall endeavor to find solutions to the challenges facing their respective industries, as well as both strengthen MC's core operations and create new businesses within those industries (efforts that shall include initiatives to identify potential growth sources).
- The Global Marketing Division shall be responsible for trade and for leveraging it to identify potential growth sources.



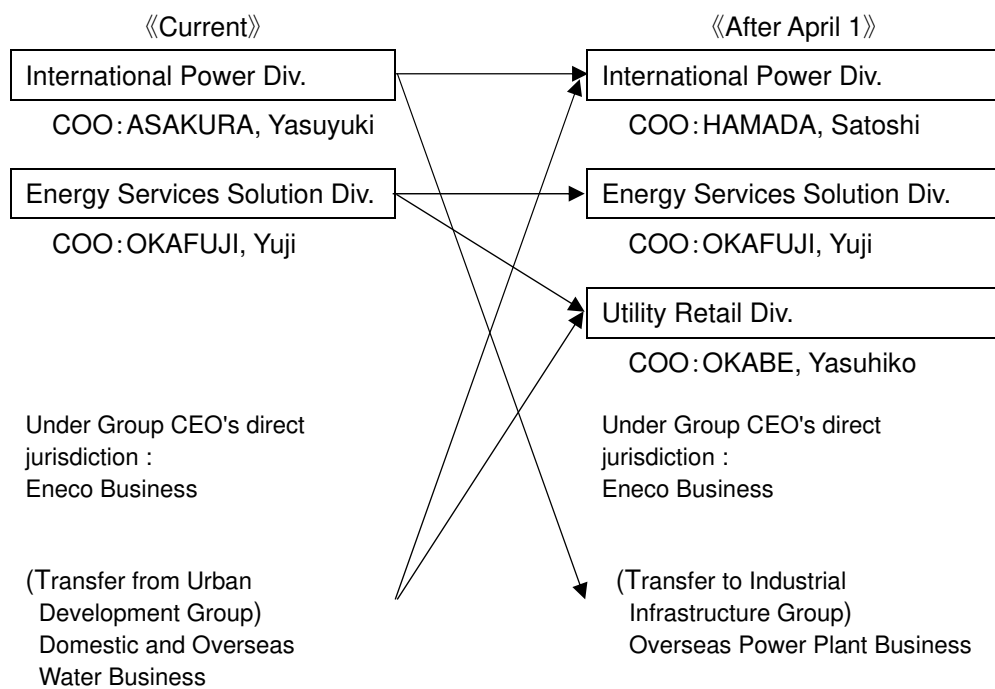
3. Food Industry Group

- In order to strengthen connections between the sourcing and processing of raw materials, the Consumer Products Division's flour and sugar operations shall be transferred to the Food Resources Division. The Group CEO shall directly oversee all new markets (Indonesia & Myanmar) development businesses.
- The Global Fast Moving Consumer Goods Division shall be newly established in order to promote connectivity between the Food Industry Group's overseas consumer goods manufacturing operations in North America, Europe and Asia, and its global operations in food and beverage materials, such as those with Olam International.
- The Fresh Food Products Division shall be reorganized into the Produce & Marine Products Division, which shall be responsible for businesses in marine products, rice, fruits and vegetables. The Group CEO shall directly oversee all livestock, meat products, and dairy products businesses.



4. Power Solution Group

- The Utility Retail Division shall be newly established in order to promote and strengthen retail operations under the Power Solution Group's unified power generation and sales strategy.
- Both domestic (in Japan) and overseas water businesses shall be transferred to the Power Solution Group from the Urban Development Group, the Japanese operations to be covered by the Utility Retail Division and the overseas operations by the International Power Division. Overseas power plant operations shall be transferred from the Power Solution Group to the Plant Engineering Division of the Industrial Infrastructure Group.
